## Outstanding Achievement Awards Committee Report

For the 2024-2025 academic year, I served as the Faculty Senate representative to the Outstanding Achievement Awards (OAA) Committee. While OOA does not have a website or formal charge, the committee is comprised of Mason faculty and staff who represent various units and campuses across the university. The goal of the committee is to review redacted packets and score nominations, against scoring rubrics, to identify the recipients for the April OAA ceremony. Led by Human Resources' Stacey Ellis, she divided the committee members into several different scoring groups because of the sheer number of nomination packets to review. The specific award categories:

- Hattery Award (for a University Life or Housing and Residence Life employee)—4
  representatives, 2 from each of those areas
- Patriot Pathbreakers (jointly sponsored by Human Resources and Staff Senate)—5
   representatives: 3 from Staff Senate, 2 from Human Resources
- All other categories—1 Faculty Senate representative, 1 Staff Senate representative, 1 Human Resources representative, 1 representative from Mason Square, 1 representative from Science and Technology (SciTech), 1 representative from the Front Royal Campus

The Human Resources team revamped the awards categories this year to more fully align with the university's mission and values. This year, there was an 146% increase in nominations!
